



5. The Licensee expected these materials to be picked up by his trash collection service and brought directly to the area waste facility for incineration. However, all of the disposed materials and records remained outside overnight and were not picked up until the afternoon of April 23, 2001.

#### AGREEMENT


In lieu of proceeding to an adjudicatory hearing, the Licensee, the Board and the Department of the Attorney General agree to the following:

1. The Licensee's method of disposing of old medical supplies, equipment and records was inappropriate.
2. The inappropriate disposal of medical supplies, equipment and medical records is unprofessional conduct as defined by 32 M.R.S.A. § 3282-A(2)(F).
3. The Licensee agrees to accept a **WARNING** from the Board as discipline for his conduct.
4. The Licensee waives his right to a hearing before the Board or any Court regarding all findings, terms and conditions of this Consent Agreement.
5. The Licensee has been represented by Kenneth W. Lehman, Esq., who has participated in the negotiation of the terms of this agreement.

**I, CALVIN P. FUHRMANN, M.D., HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT AND AGREE WITH ITS CONTENTS AND ITS TERMS. I FURTHER UNDERSTAND THAT BY SIGNING THIS AGREEMENT, I WAIVE CERTAIN RIGHTS, INCLUDING THE RIGHT TO A HEARING BEFORE THE BOARD. I SIGN THIS CONSENT AGREEMENT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND, VERBAL, WRITTEN OR OTHERWISE.**
