SAFE PRESCRIBING

As of January 1, 2003, the use of special prescription pads has been required when Schedule II drugs are being prescribed, or a waiver must be in place to use a different product. This new prescribing law along with a study of drug deaths completed by the Department of Attorney General and the Office of the Chief Medical Examiner has focused attention on the growing problem with drug misuse in the state. An excerpted version of the executive report from this study accompanies this newsletter, with their permission. The newsletter will also review the features needed on the secure prescriptions, and requirements necessary in completing the prescription.

It is important that Maine citizens continue to receive competent and compassionate treatment of pain. It has become increasingly challenging for physicians to respond to these patients' needs while being mindful of the small number of citizens that can misuse and divert their prescription medications and actually deceive physicians to this end. There are educational sessions, pain management guidelines, and sample pain management contracts available from the Board to help meet this challenge.

FEATURES of SECURE PADS

- (1) background pantograph that reads "void" when copied
- (2) watermark visible when viewed at 45 degree angle
- (3) tamperproof to erasures by abrasion or chemicals
- (4) heat sensitive ink symbol (disappears with rubbing)
- (5) (5) 4 1/4" by 5 1/2" size
- (6) name, address, phone number, DEA number of prescriber written, pre-printed, or stamped

COMPLETION of the PRESCRIPTION

- (1) circle or mark name of prescriber on a multi-name pad
- (2) write out numbers, as well as indicating numerically
- (3) one drug per one blank
- (4) emergency phone order needs written script within 7 days
